Terms and Conditions:

1. This document gives Rhythm Auctions the permission to bid on behalf of the above said name up to the maximum amount indicated. If there is no other party bidding, the auctioneer comes down to approximately half the amount shown, and then the auctioneer has the right to open the bidding on this customer's behalf. If no one bids against him, then it's sold for that amount. If then another person bids, the auctioneer takes the absentee in increments taken at that time until the price has reached the MAX bid. Absentee fees do apply even if the item is not won. Rhythm Auctions makes no 100% guarantee that the item will go to the absentee bidder, but will make every effort to do so.
2. Rhythm Auctions acts as the agent for the owner and not as the owner.
3. All items must be paid for in full on sale day and before items are removed from the premises by cash, certified cheque, Money order, debit, visa, MasterCard, e-transfer or wire transfer to Rhythm Auctions. We can only do a maximum of \$5000 per transaction on credit card purchases but can do multiple transactions for the amount of the buyer's purchase. Applicable taxes GST and PST will be added to the bid price plus a Buyer's premium if charged at the auction onsite. Buyer's Premium will only be charged at some specific auctions. Any items not paid for on sale day may at the option of the auctioneer be resold at any subsequent sale at any deficiency charged to the buyer.
4. All items sell on an "as is where is" basis no warranty implied or otherwise exists and are at the Buyer's risk and responsibility as soon as the auctioneer has declared they are sold and has declared your bidding number. Any warranty offered by the seller shall be a matter between the seller and the buyer and shall not involve the auction firm. Any information provided by the auctioneer is meant as a guide only. All buyers shall inspect each item and satisfy themselves as to the condition, fitness, quantity, soundness, and/or to the measurements of the items before bidding and shall not be permitted to make any objections after the sale on any grounds whatsoever. Rhythm Auctions, its employees, and the seller accept no responsibility for errors in advertising or description. Once the buyer has bought an item it becomes the buyer's responsibility. Rhythm Auctions will not be liable for any damages, theft or insurance on purchased items.
5. All items must be removed from the premises from the sale location within the time announced by the auctioneer or they will become liable to storage charges and may at the option of the auctioneer after notice to the buyer be resold at any deficiency charged to the buyer.
6. The auctioneer reserves the right to accept or reject any bid and in cases of dispute the auctioneer's decision shall be final. When the auctioneer declares an item "sold" and more than one bidder claims to have the highest bid the auctioneer may declare who the highest bidder was or re-open the bidding.
7. N.S.F. cheques or stoppage of payment will be turned over to legal authorities and all costs will lie at the buyer's expense.
8. Rhythm Auctions, their employees and staff are not liable for any injuries sustained to any personal nor for any damages to or loss of property which may occur from any cause whatsoever.
